PET CARE AGREEMENT

This agreement is between Fieldstone Animal Inn and the above named Pet Owner. Fieldstone Animal Inn agrees to exercise due and reasonable care of pets, and to keep the premises sanitary and properly enclosed. If the pet becomes ill or if the state of the pet's health otherwise requires professional attention, Fieldstone Animal Inn, in its sole discretion, may engage the service of a veterinarian of its choosing, or administer medicine, or give other required attention to the pet, and expenses thereof will be paid by the Pet Owner. Fieldstone Animal Inn will only release pets to their owners unless other arrangements have been made with facility management. Fieldstone Animal Inn reserves the right to decline boarding services to any pet it deems necessary and further reserves the right to turn over to Anne Arundel Animal Control any pet deemed abandoned by its owner.

The Pet owner assumes responsibility for all charges incurred in the care of their pets. The Pet Owner agrees that all charges incurred shall be payable upon pick-up of the pet. The Pet Owner further agrees to provide prior notice to Fieldstone Animal Inn should a pet's stay need to be extended past the original departure date and that a deposit will be required to extend a pet's stay.

Fieldstone Animal Inn does not guarantee the return of items left with pets nor the condition of any returned items.

It is understood by Fieldstone Animal Inn and the Pet Owner that all provisions of this contract shall be binding upon both parties for this visit and for all subsequent visits.
