____ Fieldstone agrees to exercise due and reasonable care of pets, and to keep the premises sanitary and properly enclosed. If the pet becomes ill or if the state of the pet's health otherwise requires professional attention, Fieldstone, in its sole discretion, may engage the service of a veterinarian of its choosing, or administer medicine, or give other required attention to the pet, and expenses thereof will be paid by the Pet Owner.

____ Fieldstone will only release Pets to the Pet Owner unless other arrangements have been made with facility management.

____ Fieldstone reserves the right to decline boarding services in its sole discretion and further reserves the right to release Pet to Anne Arundel Animal Control if the Pet is deemed abandoned by the Pet Owner. (Abandoned means Pet has not been claimed within 30 days of the scheduled departure date.)

____ Fieldstone does not guarantee the return of personal items left with pets nor the condition of any returned items.

____ The gravel in our outdoor area can possibly make Pet's feet sore.

____ If the Pet will be playing with other pets, please acknowledge that dogs play with their teeth and claws and can sometimes get scratched/bitten.

Pet Owner assumes responsibility for ALL CHARGES incurred in the care of Pet. Pet Owner agrees that all charges incurred are payable upon pick-up of Pet. Pet Owner further agrees to provide prior notice to Fieldstone if Pet's stay needs to be extended past the original departure date and that a deposit will be required to extend a pet's stay. The provisions of this contract shall be binding upon both parties for this visit and for all subsequent visits unless changed in writing.

Terms and Conditions: Fieldstone will provide services in a professional and humane manner consistent with industry standards reasonably applicable to the services provided without any warranties, express or implied, unless written otherwise. ABSENT GROSS NEGLIGENCE, FIELDSTONE SHALL NOT BE LIABLE FOR ANY DIRECT OR CONSEQUENTIAL DAMAGES OF ANY KIND, ARISING OUT OF OR IN CONNECTION WITH ANY ACT OR OMISSION, AND IN NO EVENT SHALL LIABILITY PURSUANT TO THE SERVICES PROVIDED EXCEED THE TOTAL FEES PAID BY PET OWNER. In the event that Pet Owner is not satisfied with services received and/or wishes to dispute an invoice amount, Pet Owner must first notify Fieldstone within thirty (30) days of receipt of services or invoice, whichever is later, in writing by certified mail fully stating the nature of the dissatisfaction, and allow Fieldstone thirty (30) days to correct any perceived deficiencies. Pet Owner's failure to follow this notification provision will bar any subsequent efforts by Pet Owner to dispute the validity or amount of any balance due or quality of services received. Pet Owner shall reimburse Fieldstone for any costs, attorney's fees, and expenses incurred in connection with the enforcement of this contract, including collection efforts, or the successful defense of any legal right or remedy, whether in whole or in part.
